UNITED STATES AND CANADIAN LOCATIONS

- Rates shown are per day, are not discountable and require an advance reservation confirmation. Weekly Business Rates are 7 times the above daily rates. **All one day rentals in the U.S. commencing between Monday and Thursday will be assessed an additional \$5.00 surcharge. All one day rentals in Canada commencing between Monday and Thursday will be charged an additional \$5.00 One/day surcharge with the exception of Calgary and Vancouver.** For rentals of car classes G and above, a 10% discount on Leisure rates will apply. Rates/benefits are available at participating locations, are subject to availability of vehicles and may be blacked out during certain periods.
- Rates include unlimited miles/kilometers per day and liability protection to the extent provided in the applicable rental agreement. Rates/benefits do not apply to one way rentals and rentals where cars are not returned to the original renting location.
- The following additional charges may apply: vehicle licensing fees, airport fees, or airport/hotel concession fee recoveries. Governmental surcharges, taxes, tax reimbursement and optional items, such as refueling or additional driver fees, are extra. Optional Loss Damage Waiver (LDW), Liability Insurance Supplement (LIS), Personal Accident Insurance and Personal Effects Coverage (PAI and PEC) are not included in rates. In Canada, depending on the rental location, an Air Conditioner Surcharge Recovery fee per day may apply. No discount will apply to such charges.
- Business Account Rates are not available weekends (12:01a.m. Friday through 3:00 p.m. Sunday) and holidays at JFK airport, LaGuardia airport, Newark airport and the New York Metro tri state area.
- Renters must meet standard driver and financial responsibility standards. Minimum rental age in the U.S. and Canada is 25.

INTERNATIONAL LOCATIONS

Throughout Europe special reduced rates are available at certain locations. Otherwise, a 5% discount off Affordable Europe Non-Prepaid rates will apply. In Africa, Australia, Asia Pacific Region, Latin America, Middle East and New Zealand a 10% discount will apply on national time and kilometer rates or the best available rate will apply. Rates are based on local currency and will vary by country and, where applicable, by law. At many airports and some other locations, a service charge applies.
